

Government Foundation Meeting

April 7, 2009

Trent Ashby called the meeting at the Angelina County Chamber of Commerce to order at 7:30 AM at the Lufkin/Angelina Chamber of Commerce.

Appointment to State Boards:

Trent Ashby reported that within the past two months, four special appointments from Angelina County have been made to State Boards. They include the following:

Tom Gann - Texas Department of Housing and Community Affairs Jody Anderson – Angelina Neches River Authority Rodney Moore – Texas Public Financing Authority Barbara Mathis – One Call Board

There is still a need for representation from East Texas and Trent requested that names of any potential board members be forwarded to him as soon as possible. Trent will send out again the list of potential board members that was put together earlier. There will be more vacancies coming up at the end of 2009 and this will be an on-going effort to fill some of these with East Texans.

Census:

Kyle Mence, Partnership Specialist, Dallas Regional Census Center of the U.S. Census, gave an update on the upcoming Census. Kyle, born and raised in Lufkin and currently living in Livingston, is very familiar with East Texas and their historically low mail-in response. He is holding a training session on April 9th from 10:00 a.m. until noon in the Chamber Board Room for the committee that has been put together to oversee the Census efforts in our area. The training will be how to educate and get the word out that the Census is safe with focus on reaching the minorities and economically disadvantaged. Angelina County has done so much preparation for this upcoming Census that Houston is looking at Angelina County as a model to follow.

The local Census team consists of committee and subcommittees of the following people:

The first event on the calendar for the Census team will be Cinco de Mayo. The team will have a manned booth with educational materials. The Census has about \$3 million to award annually for various projects such as highways bridges, hospitals, etc. One of the goals of this group is to receive an appropriate portion of these funds for use in Angelina County.

Economic Development:

Jim Wehmeier gave a legislative update on some of the bills pending that would effect Angelina County. These include the following:

- \$450,000 for water infrastructure to benefit Lufkin on a federal level
- A bill for the state schools regarding the authority to close them is probably dead.
- A bill for purging the State Schools down to 3,000 residents and placing them into community-based homes – still pending
- A bill to create a Rural Development Fund (state funded) still pending
- A bill to allow Nacogdoches/Angelina County to have a county hotel/motel tax still pending
- A bill to establish a regional emergency response management depot here in Lufkin to warehouse emergency supplies – still pending

Mark Dunn requested a list of projects that would help the City and/or County from Paul Parker and Jim Wehmeier. These will be proposed by the Rotary Club for possible funding.
